## Corporate Voice: SIP Trunking

1. **Definitions-** The following definitions apply, in addition to those in the General Business Terms and Conditions and the General Fixed Services Schedule of the MSA.

DID	Means Direct Inward Dialling. Vodafone, at customer request, allocates a range of numbers associated with one or more phone lines. Its purpose is to allow the customer to assign a personal number to each employee, without requiring a separate phone line for each.
CPE router	Means Customer Edge Router which is typically installed at customer premises. It connects to the provider edge router.
PBX	Means Private Branch Exchange - a private telephone network used within an enterprise. Users of the PBX share a certain number of outside lines for making telephone calls external to the PBX.
PSTN	Public Switched Telephone Network - is the world's collection of interconnected voice-oriented public telephone networks, both commercial and government-owned.

## 1. Tariff Terms and Conditions

- 1.1 Vodafone's General Business Terms and Conditions and the General Fixed Services Schedule of the Master Service Agreement ("MSA") apply.
- 1.2 Vodafone service is available only in those areas where Vodafone has fixed coverage. However, currently Vodafone is unable to provide this service in the Pearl development.
- 1.3 Where a product or service which a Customer uses has specific terms and conditions published on our website and/or other marketing material, those specific terms and conditions will also apply.
- 1.4 Vodafone may from time to time offer and publish promotions that modify this tariff document, and such modifications will apply for the stipulated time.
- 1.5 The minimum contractual period shall be three (3) months ("Minimum Subscription"). Cancellation of the Service prior to that time will result in applicable charges due and payable for the entire three month Minimum Subscription period.

## 2. Service Description

2.1 A SIP trunk is a service, comprised by a predefined number of voice channels, offered by Vodafone to set up communications between a customer PBX and the PSTN. The CPE Router for Vodafone's SIP trunking, enterprise customers, will be provided by Vodafone. Vodafone will extend the SIP trunking connectivity to a customer's premise. Vodafone will



install and configure the CPE Routers at the customer premise. Customer will be responsible for PBX connection to Vodafone CPE and for PBX configuration and maintenance.

2.2 **Service Delivery:** Vodafone will install the core component and the required local access circuit and conduct a series of tests on the Vodafone provided Services to confirm that the Service is operational. Currently Vodafone is unable to provide this service in the Pearl development.
