Terms and Conditions

- 2. The following scope of work will include:

 - 2.2 Installation of the telematics devices in the client's vehicles at either Qatar Science & Technology Park (QSTP Vodafone) or client's location within Doha.
 - 2.3 Provide a web portal that monitor real-time the GPS telematic devices
 - 2.4 Manage service and operation support during the contract duration
- 3. Fleet Management Services include the following deliverables:
