1. Tariff Terms and Conditions

- 1.1 Vodafone's Business General Terms and Conditions and General Fixed Services Schedule of the Master Service Agreement ("**MSA**") shall apply.
- 1.2 Vodafone Office Fixed Voice & Broadband bundle ("**Business Broadband Service**") is available only in those areas where Vodafone has fixed coverage.
- 1.3 Where a product or service that a customer uses has, specific terms and conditions published on our website and/or other marketing material, those specific terms and conditions will also apply.
- 1.4 Vodafone may from time to time offer and publish promotions that modify this tariff document, and such modifications will apply for the stipulated time.
- 1.5 The minimum contractual period shall be three (3) months ("**Minimum Subscription**") excluding any free promotional months. Cancellation of the Service prior to that time will result in applicable charges due and payable for the entire remaining months of the three (3) months Minimum Subscription period.
- 1.6 The minimum contractual period for the OSNtv Commercial Premium service shall be (12) months. This minimum contractual period shall be renewed every (12) months as long as the service is active.
- 1.7 Vodafone may as per Article 3.9 of the Retail Tariff instructions ("**RTI**") may offer up to 20% discount on the products or services from time to time on permanent or promotional basis.

2. Service Description

The Business Broadband Service enables customers to access the internet through the Vodafone fixed network. Customers will be able to achieve speeds up to 1 Gbps.

3.1 With the exception of the 75 Mbps and the 800 Mbps plans, all the plans above will have only internet and no landline voice service. Customers who wish to subscribe for landline voice service will have to pay QAR 150 per month in addition to the plan charges.

3.2 Customers with landline subscription will receive unlimited free local minutes to any landline in Qatar, and up to 1000 minutes to any mobile in Qatar as mentioned below:

- 30 Mbps – 200 Local mobile minutes
- 75 Mbps – 300 Local mobile minutes
- 100 Mbps – 400 Local mobile minutes
- 250 Mbps – 600 Local mobile minutes
- 500 Mbps – 800 Local mobile minutes
- 800 Mbps – 900 Local mobile minutes
- 1Gbps – 1000 Local mobile minutes

3.4 Microsoft 365 License Offering

1. A single license user can install Microsoft 365 office applications to a maximum of 5 devices.
2. Microsoft 365 Business Basic will be offered at a 52% discount on the list price to customers on selected Business Broadband plans purchased provided Customer does not disconnect the Business Broadband Services for a minimum of twelve (12) months.
3. If the Customer disconnects the Business Broadband services prior to the minimum 12 months contract period, a penalty charge will be applied, or Customer can continue using as a stand-alone product based on the List Price. Penalty for the Microsoft 365 Business Basic license will be charged on a pro-rate basis (E.g.: If the Customer purchases the discount offer on 1 January and disconnects the Business Broadband services on 31 March, a penalty will be charged as per the List Price for the remaining 9 months (April to December) out of the 12 months contract period.
4. Customer also can migrate Business Broadband bundle offer to stand-alone license service if they wish to discontinue the broadband services. At this time a new order form for Microsoft 365 services should be signed, and the price will change according to the Vodafone Pricelist.
